The Capital Market Development Council (CMDC), the Bangko Sentral ng Pilipinas, the Insurance Commission, the Securities and Exchange Commission, and Asian Development Bank (ADB) will jointly organize a workshop on "Green Social Sustainable Bonds Series 4: Creating Sustainable and Responsible Investment Portfolios" on 30 July 2021, from 1:00-3:30pm Manila time.

The objectives of this workshop are to: (i) discuss how to develop and implement robust methodologies for building climate-friendly portfolios, (ii) provide overview of recent bond market development and future trends in ASEAN+3, and (iii) explain role of institutional investors in supporting sustainable bond market development in the Philippines.

ADB serves as the secretariat to the Asian Bond Markets Initiative (ABMI) which is under the ASEAN plus the People's Republic of China, Japan, and the Republic of Korea (collectively known as ASEAN+3). The ABMI was launched in 2002 by the Finance Ministers and Central Bank Governors of the ASEAN+3 member countries to boost development of local currency bond markets to help mitigate the currency and maturity mismatch problems.
