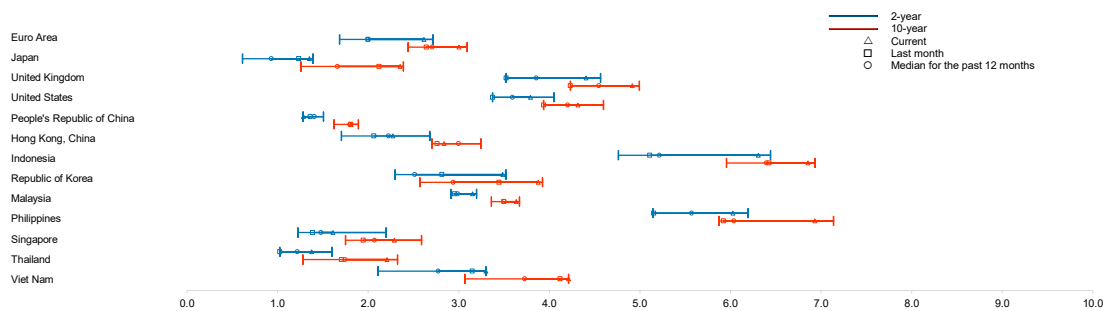

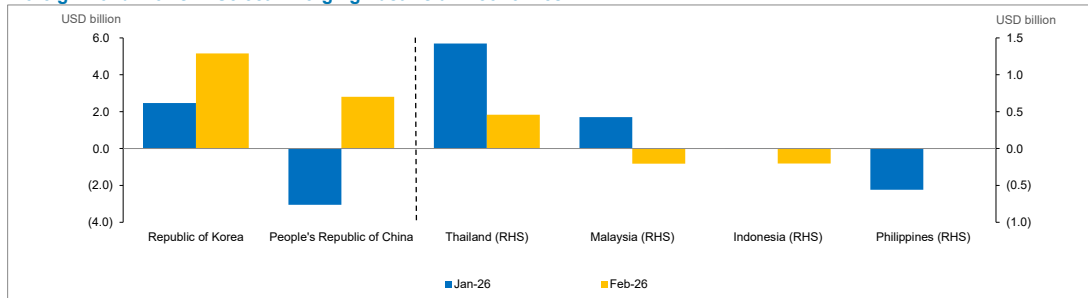

2. Figures were computed based on 28 February 2026 exchange rates to avoid currency effects. For January 2026, Indonesia recorded net bond inflows of USD0.01 billion. For the Philippines, data for February 2026 were not yet available.
