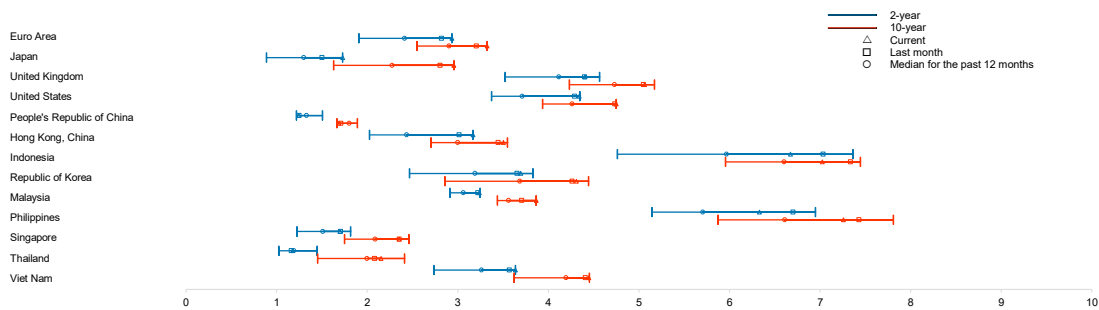

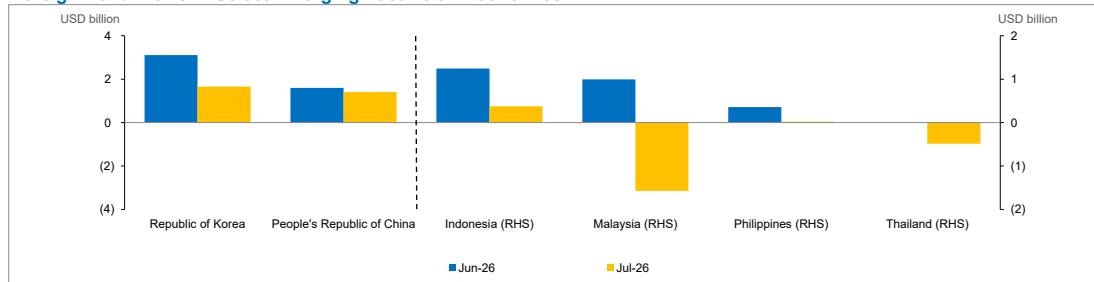

3. Thailand recorded net outflows of USD73.747 in June 2026. The Philippines recorded net inflows of USD0.02 billion in July.
